## Section 4. First aid measures

### Description of necessary first aid measures

## Section 5. Firefighting measures

### Extinguishing media

**Suitable extinguishing media:** Recommended: alcohol-resistant foam, CO<sub>2</sub>, powders, water spray.

## Section 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

**For non-emergency personnel:** No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Exclude sources of ignition and ventilate the area. Avoid breathing vapour or mist. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilt material. Put on appropriate personal protective equipment.

**For emergency responders:** If specialised clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For non-emergency personnel".

**Methods and material for containment and cleaning up** Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and



place in container for disposal. Preferably clean with a detergent. Avoid using solvents.

## Section 7. Handling and storage

### Precautions for safe handling

#### **Protective measures:**

Put on appropriate personal protective equipment (see Section 8).

#### **Advice on general occupational hygiene:**

Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. #### **Conditions for safe storage, including any incompatibilities:**

Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from heat and food and drink. Keep container tightly closed and sealed until ready for use. Store between 5 and 35 °C in a dry, well ventilated place away from sources of heat, ignition and Direct sunlight. Do not freeze. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Keep away from sources of ignition. Do not store in unlabelled containers. Use appropriate containment to avoid environmental contamination.

## Section 8. Exposure controls/personal protection

### Control parameters

#### Occupational exposure limits

#### **Appropriate engineering controls:**

Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

#### **Environmental exposure controls:**

Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. In some cases, fume scrubbers, filters or engineering modifications to the process equipment will be necessary to reduce emissions to acceptable levels.

### Individual protection measures

## Eye/face protection:

If contact is possible, the following protection should be worn, unless the assessment indicates a higher degree of protection: safety glasses with side-shields.

## Skin protection

### Hand protection:

There is no one glove material or combination of materials that will give unlimited resistance to any individual or combination of chemicals.
