### Methods and material for containment and cleaning up

Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. Avoid generation and spreading of dust. Avoid contact with skin or inhalation of spillage, dust vapor. Wear necessary protective equipment. Containers with collected spillage must be properly labelled with correct contents and hazard symbol.

### Precautions for safe handling

#### **Protective measures:**

**Advice on general occupational hygiene:**

Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool, well-ventilated area. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. Use appropriate containment to avoid environmental contamination.
